CAMPUS SAFETY

Campus Crimes, Fires and Other Emergencies Activity Report (PL2015, Chapter 220, S485) in accordance with N.J.S.A.C. 18A:3B-71: There were no fires for the period of May 1-31, 2024. There was one criminal incident for the period of May 1-31, 2024. The criminal incident involved a report to Public Safety of sexual assault; see below for more information.

The Clery Act: There were no reported criminal offenses, hate crimes, nor arrests or referrals for disciplinary action related to weapons, drugs, or alcohol possession during the period of May 1-31, 2024. There was one VAWA offense reported on May 17, 2024: a student filed a report of sexual assault with Randolph Police for an incident which allegedly occurred on May 8, 2024, in parking lot 8 on campus. Randolph Police and Public Safety worked concurrently on the investigation; Randolph Police for criminal investigation and Public Safety for Title IX and Code of Conduct violations. The student filing the report did not want to pursue a criminal investigation but did file a Title IX complaint with the College.
