#### BOARD OF SCHOOL ESTIMATE OF COUNTY COLLEGE OF MORRIS <u>Meeting Minutes</u> February 13, 2024

College Attorney Richard Flaum, who was designated as the Chair Pro Tem, called the meeting of the Board of School Estimate of County College of Morris to order at 12:06 p.m. The meeting was held virtually via Zoom web conferencing.

Attorney Flaum read the following public announcement ..

In compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of the February 13, 2024 meeting of the Board of School Estimate of County College of Morris, in the form attached, was provided in the following manner:

On February 1, 2024, advance written notice of this rescheduled meeting was posted by the Board of County Commissioners on the bulletin board, Commissioners' Office, 5th Floor, Administration and Records Building, Morristown, New Jersey, and on the bulletin board outside the President's Office, County College of Morris. On February 1, 2024, advance written notice of this meeting was sent to the Daily Record, Star Ledger and filed with the Clerk of the County of Morris.

Voting members Morris County Commissioner Director Christine Myers, Commissioner Deborah A. Smith, County College of Morris Board of Trustees Chair George J. Milonas, and County College of Morris Trustee Treasurer Jack Frost were in attendance. Morris County Commissioner John Krickus was absent. Also in attendance were County College of Morris Trustee Secretary Lauren Inganamort; County College of Morris President Anthony J. Iacono, College Attorney Richard Flaum, and Vice President Karen VanDerhoof.

Attorney Flaum stated that, pursuant to law (N.J.S.A. 18A:64A-16), Trustee Lauren C. Inganamort, Secretary of the Board of Trustees of County College of Morris, is automatically Secretary of the Board of School Estimate. Trustee Secretary Inganamort assumed the duties of Secretary for this meeting.

Trustee Secretary Inganamort acknowledged prior receipt of confirmation from the County Commissioners that Commissioner Krickus and Commissioner Smith have been appointed to this Board. Pursuant to law (N.J.S.A. 18A:64A-15), Commissioner Director Myers is automatically a member of this Board. Trustee Secretary Inganamort also acknowledged confirmation from the Board of Trustees of County College of Morris that Chair George J. Milonas and Treasurer Jack N. Frost have been appointed to this Board. Trustee Lauren Inganamort was designated as an alternate member.

Commissioner Director Myers nominated Commissioner Smith for the permanent Chair of the Board of School Estimate for 2024. Trustee Treasurer Frost seconded the nomination. There being no further nominations, voice vote of the Board indicated that all present were in favor of the election of Commissioner Smith as Chair.

Commissioner Smith called for the election of the Vice Chair of the Board of School Estimate for 2024 and nominated Commissioner Director Myers to the position of Vice Chair of the Board of School Estimate for 2024. Trustee Chair Milonas seconded the motion. Voice vote of the Board indicated that all present were in favor of the election of Commissioner Director Myers to Vice Chair of the Board of School Estimate for 2024.

Commissioner Smith provided the motion for consideration of the minutes of the Board of School Estimate meeting held on April 13, 2023. Upon the second of Trustee Treasurer Frost, voice vote indicated that all Board of School Estimate members present were in favor of accepting the minutes of April 13, 2023, as written.

Secretary Inganamort noted that written notice of the February 13, 2024 meeting was forwarded to all members on February 1, 2024 as required by the Bylaws, together with a copy of the resolutions of the Board of Trustees, with itemized statements in explanation thereof attached. Commissioner Smith called for consideration of the budget for fiscal year commencing July 1, 2024 and provided the motion certifying \$82,325,218 as the amount needed for the operating budget of the College for the fiscal year commencing July 1, 2024 and \$12,105,000 as the County's share. Trustee Chair Milonas seconded the motion.

#### The resolution is as follows:

WHEREAS, The Board of Trustees of County College of Morris has delivered to each and every member of this Board of School Estimate of County College of Morris, a certified copy of a resolution with itemized statement in support thereof, adopted by said Board of Trustees on January 30, 2024, estimating that the amount of money necessary for the operating budget of the College for the fiscal year commencing July 1, 2024, is \$82,325,218; and

WHEREAS, This Board has met and considered the said resolution and statement of the Board of Trustees and is satisfied that the sum set forth therein is the amount of money necessary for the purpose set forth in said resolution and statement of the Board of Trustees;

NOW, THEREFORE, BE IT RESOLVED, That this Board of School Estimate of County College of Morris does hereby fix and determine that the amount of money necessary for the operation of the College for the fiscal year commencing July 1, 2024--exclusive of the amounts expected to be received from the State and other sources--is \$12,105,000.

BE IT FURTHER RESOLVED, That a certificate of said amount so fixed and determined shall be made and executed in accordance with the law, and copies of said certificate shall be delivered to the Board of Trustees of County College of Morris and the Board of Chosen Commissioners of Morris County, each accompanied by a copy of the said resolution and itemized statement received from the Board of Trustees of County College of Morris.

Trustee Secretary Inganamort announced that the itemized annual budget request for 2024-2025 was published in the Daily Record on February 1, 2024, pursuant to law (NJSA 18A:64A-17).

Commissioner Smith called for discussion of the resolution by Board members. The Board of School Estimate members compared the budget to the prior year. It was noted by Trustee Treasurer Frost that the budget is based on no increase in tuition or college fee. There being no further discussion by members of the Board of School Estimate, Commissioner Smith opened the meeting to the public for comments and questions at 12:13 p.m. There being no public discussion, the meeting was closed to the public.

A roll call vote of the Board of School Estimate indicated that all members present were in favor of the adoption of the County College of Morris 2024-2025 college budget certifying \$82,325,218 as the amount needed for the operating budget of the College for the fiscal year commencing July 1, 2024 and \$12,105,000 as the County's share.

Commissioner Smith called for consideration of the resolution to fix and determine the amount of money needed for certain Chapter 12 funded capital projects. Trustee Treasurer Frost provided the motion. Trustee Chair Milonas seconded the motion.

The resolution is as follows:

WHEREAS, The Board of Trustees of County College of Morris has delivered to each and every member of this Board of School Estimate of County College of Morris a certified copy of a resolution adopted by said

Board of Trustees on January 30, 2024, estimating that the amount of money necessary for building expansion is \$4,200,000; and

WHEREAS, This Board has considered the January 30, 2024 resolution of the Board of Trustees and is satisfied that \$4,200,000 is necessary to fund these projects;

NOW, THEREFORE, BE IT RESOLVED, That this Board of School Estimate of County College of Morris does hereby fix and determine that the sum of money needed, and the amount to be raised by the County for building expansion is \$4,200,000 or an amount equal to the Chapter 12 funding, whichever is less. It is expected that \$2,100,000, will be received for said purpose as State aid, including \$2,100,000 to be provided pursuant to Chapter 12 of the Laws of 1971. The County share of the cost is expected to be \$2,100,000 or an amount equal to the Chapter 12 funding, whichever is less, to be raised by the County of Morris bond ordinance or other means authorized by law.

IT IS FURTHER RESOLVED, That a certificate of the amount so fixed and determined shall be made and executed in accordance with the law and copies delivered to the Board of Trustees of County College of Morris and the Board of County Commissioners of Morris County, each accompanied by a copy of the January 30, 2024 resolution and statement received from the Board of Trustees of County College of Morris.

Commissioner Smith called for discussion of the resolution by Board members. There being no discussion by members of the Board of School Estimate, Commissioner Smith opened the meeting to the public for comments and questions at 12:15 p.m. There being no public discussion, the meeting was closed to the public.

A roll call vote of the Board of School Estimate indicated that all members present were in favor of the resolution to fix and determine the amount of money for certain Chapter 12 funded capital projects.

There being no further business to be conducted by the Board of School Estimate at this meeting, the meeting was adjourned at 12:16 p.m. upon a motion from Commissioner Smith and seconded by Commissioner Director Myers. The voice vote indicated that all Board of School Estimate members present were in favor. The meeting adjourned.

WHEREAS, the estimated cost of the building expansion (the "Project") is \$4,200,000 (of the amount so estimated, the sum of \$2,100,000 is to be provided pursuant to Chapter 12 of the Laws of 1971); and

#### APPROVAL OF CAPITAL PROJECTS

The Board of Trustees of County College of Morris has determined the funding for the capital expenditures will be \$4,200,000;

The funding is to be shared between the State and the County;

The State share will be \$2,100,000 and the County share will be \$2,100,000.
