1. CALL TO ORDER

Upon the motion of Trustee Mislavsky and the second of Trustee Loveys, Vice Chair Inganamort called for discussion by members of the Board. There being no discussion, Vice Chair Inganamort called for a voice vote of the Board. The voice vote of the Board indicated that all present were in favor. The meeting was closed to the public at 6:04 p.m. The public meeting reconvened at 6:36 p.m. via Zoom web conference.

6. REPORT OF THE PRESIDENT

President Iacono referred the Board to the written Report of the President that is on file with the Office of the President and posted on the webpage with materials for this Trustee meeting. The Report of the President includes information on enrollment, finances, Foundation fundraising, campus safety and campus safety training.

President Iacono introduced Executive Vice President Karen VanDerhoof who presented the 2025-2026 budget. EVP VanDerhoof explained that the 5.5% tuition increase, in light of having no increase last year, works out to be approximately a 2.7% increase over two years. It was possible to keep the increase so low due to increased funding from the County. President Iacono thanked EVP VanDerhoof for her hard work and the work of her team.

7. COMMUNICATIONS

A. Reports of the Standing Committees: Trustee Milonas reported on the Lands & Buildings Committee meeting highlighting the need for a resolution to amend last year's Chapter 12 funding request. Vice Chair Inganamort reported on the Finance and Budget Committee meeting, reporting on the budget and request for capital funds. Vice Chair Inganamort also reported that personnel matters were discussed in closed session.

8. RESOLUTIONS

Vice Chair Inganamort called for a motion for the adoption of the following resolutions and stated that it is the intent to take these resolutions as consent items, voted as a group, unless any Board member or College Counsel wishes to remove it from the Consent Agenda and discuss separately. Jill Schenum, Chair of the Sociology Department at County College of Morris, commented on recent federal updates.

Dee McAree, President of the Faculty Association of County College of Morris (FACCM), commented on federal funding issues, the rights of the students, and reported that "Know Your Rights" cards have been distributed by FACCM.

Michelle Altier, FACCM Pride & Pep Chair, commented on budget and tuition increases.

As there was no further public comment, the public comment portion of the meeting was adjourned at 7:22 p.m.

There being no further business to conduct, the public meeting was adjourned at 7:23 p.m. by a motion from Trustee Milonas and a second by Trustee Lash. Vice Chair Inganamort called for a voice vote of the Board. The voice vote of the Board indicated that all Trustees present were in favor.
