## A Letter to County College of Morris Nursing Students

Dear Nursing Student,

In my doctoral research, I interviewed nursing students to find out what advice they would give to you who are currently beginning their nursing education. Here are some of the strategies they used to survive, and even thrive, while in the nursing program.

#### 1. Time Management

Like you, former students were stressed by having too many responsibilities and **not enough time.** They had strong recommendations that you:

- a. Prioritize what you need to do:
  - What needs to be done right now?
  - What can take a back seat?
  - What does not need to be done at all?
  - What can you delegate?

Former students advised just focusing on the **very next step** you must take.

## b. **Organize** your day, your week, your semester:

Find an organizational scheme that works for you.

Having a realistic **plan** for studying and assignments is essential. Sticking to it is even more essential.

Former students strongly advised against procrastinating.

## c. **Balance** your time:

School will take up most of your time, but former students advised taking care of yourself.

- Take short breaks from studying, especially after exams.
- Try to sleep, eat well, and exercise.
- Find a healthy activity to help you relax, such as meditation, yoga, or mindfulness.
- Even small amounts of time spent taking care of yourself can help avoid burnout.

Balancing may also mean finding small amounts of time to spend with **friends** or **family**.

#### 2. Resources

Former students advised using material resources **and** seeking help from resourceful people.

## a. Your classmates:

These are the people who understand your challenges because they are in the same place! Cultivate relationships with your classmates. **Study groups** can be invaluable to help you get through nursing school exams. More importantly, they can be a place where you can give and receive emotional support.

#### b. Outside academic resources

You will have a textbook and websites assigned by your professors. Do not be afraid to ask **previous students** what additional resources they found helpful. They have been where you are. Additional textbooks, online practice questions, and instructional videos and modules may help you understand a concept more clearly. However, always evaluate your resources – make sure they are **reputable** and **accurate**.

## c. College resources

The College has a **Counseling and Wellness Center**. Its services are free and confidential. The counselors can provide support with study techniques, emotional concerns, resources, and family challenges. Help **is** available. **It is important** that you take advantage of it!

#### 3. One more thought

Former students encountered many things in nursing school they could not change. When this happened, they used **positive self-talks**, **gratitude**, **and reframing**. In reframing, students took a negative thought (I can't take 2 more exams!) and changed it into something more positive and manageable (Three exams done, only 2 more!).

#### Summary:

Many students have been where you are.

I wish you all the best for your nursing education and your career!

#### PHILOSOPHY OF THE NURSING DEPARTMENT OF COUNTY COLLEGE OF MORRIS

The philosophy of the Nursing Department of the County College of Morris is congruent with the mission statement of the college.

<u>PERSON:</u> We believe that each person evolves as a unique holistic being who is viewed in the context of the family and community. Each person has values, beliefs, and motives that impact daily life. The person has the right and responsibility to make decisions based on these values, beliefs, and motives in relation to their health promotion and care throughout the life span. We advocate a commitment to diversity that respects individual differences and upholds the dignity of each person.

<u>HEALTH:</u> We view health as a dynamic state of being in which the psychosocial, physical, spiritual, environmental, and cultural needs of an individual, family, or community are met. Each individual moves along a wellness-illness continuum and possesses various strengths and limitations that affect the ability to meet basic needs. Failure to adequately meet any of these needs may create health challenges that require the individual, family, and/or community to receive assistance from the healthcare system.

<u>NURSING</u>: Nursing's unique function is to assist individuals, families, and communities during all stages of development to achieve optimal health through evidence-based practices. The nursing process is used in health promotion and maintenance as well as in diagnosing and treating human responses to actual or potential health problems. Nursing decisions are based on clinical judgment regarding the needs of each individual, family, or community requiring assistance in meeting optimal health goals. Nursing is an integral part of health care and performing independent, collaborative, and dependent functions.

<u>ENVIRONMENT:</u> Nursing takes place in any environment where individuals, families, and communities-need care, information, or advocacy.

TEACHING-LEARNING PROCESS: We believe faculty are the facilitators of the teaching/learning process and are committed to the educational and professional development of the students. We believe faculty can more effectively bridge the gap between the classroom and practice by adhering to current best nursing practices. We recognize that both students and faculty members possess unique differences in educational and cultural backgrounds as well as experiences that influence their learning and enrich the educational experience of the group. We believe that students learn through active participation in a variety of sequential learning activities designed to meet the needs of the individual learner using evidence-based teaching methods. The dynamic teaching-learning environment is systematically evaluated by students, faculty, administration and the community. Curriculum changes are based on ongoing evaluation processes as well as changes and progress in educational, technological, and health care practice reflecting a commitment to excellence in teaching.

The educational program includes courses offered to the general College community in the humanities, natural and social sciences, as well as courses in nursing. We

believe that the education for associate degree nursing practice benefits from the collaborative, multi-disciplinary College setting. The broad academic basis nurtures the ability of the student to respond to personal, communal, and global relationships with greater sensitivity and insight. The course of study stresses cultural competence and the ability of the student to think critically about global health and health disparities. The educational program prepares the student to become a self-directed learner with a commitment to lifelong learning and a spirit of inquiry. The educational program is guided by the National League for Nursing Educational Competencies for Graduates of Nursing Programs.

The practice of a graduate from an Associate Degree Nursing Program is characterized by accountability, competency, integrity, and caring and is congruent with the American Nurses Association (ANA) Scope and Standards of Practice. The associate degree nurse uses assessment and nursing diagnoses to form the basis for nursing interventions that are theory and evidence-based, and whose outcomes can be measured. The graduate exhibits a working knowledge of information and communication technologies. The associate degree nurse is able to manage health care needs of individuals, families and communities through an understanding of the principles of advocacy, communication, collaboration, and delegation within the legal parameters of nursing practice. As a member of the discipline of nursing, the associate degree graduate practices within the ethical and legal framework of nursing and exhibits a commitment to professional development.

#### ORGANIZING FRAMEWORK

The Organizing Framework of the CCM curriculum is based on Human Needs theory using a holistic approach. This theory is operationalized using the nursing process and applied by use of the acronym PERSON\*.

A holistic approach supports the assessment, diagnosis, planning, intervention, and evaluation of care for the total person. This approach considers the physical, emotional, social, spiritual, intellectual, and cultural stresses and their impact on the whole patient. The nurse uses the nursing process when evaluating the patient at any point on the wellness-illness continuum. A patient may be an individual, a family, a group, or a community.

Human Needs theory is the most basic to the nursing process. A problem exists when an individual's ability to meet a need is interrupted. Maslow has outlined our basic needs in a hierarchy.

Recognition of unmet needs is made evident from information the nurse has gathered in the assessment. An unmet need constitutes a problem. The problems that nurses are most involved with are in the areas of physical and emotional health. Problems are formulated into nursing diagnoses and are listed in order of priority. Assessment, planning, intervention, and evaluation are ongoing until the need is met.

\*The application of Human Needs theory occurs using the acronym PERSON. The individual's needs are P-Psychosocial, E-Elimination, R-Rest and Activity, S-Safe Environment, O-Oxygen, N-Nutrition. Illness may develop when an individual is unable to meet one or more of these needs. This failure may create a health problem that is addressed using the nursing process, the ongoing evaluation process as well as changes in educational, technological, and health care practice.

## **ACCREDITATION**

#### **GRADUATE OUTCOMES**

The Nursing Program of the County College of Morris, which leads to an Associate Degree in Applied Science, is accredited by the New Jersey Board of Nursing and the Accreditation Commission for Education in Nursing. These accreditations qualify graduates of the Nursing Program to sit for the National Council Licensure Examination for Registered Nurses (NCLEX-RN).

Value Professional Identity by implementing one's role as a nurse in ways that reflect integrity, responsibility, ethical practices, and an evolving identity as a nurse committed to evidence-based practice, caring, advocacy, and safe, quality care for diverse patients within a family and community context.

Demonstrate a Spirit of Inquiry by examining the evidence that underlines clinical nursing practice to challenge the status quo, question underlying assumptions, and offer new insights to improve the quality of care for patients, families, and communities.

#### COURSE DESCRIPTIONS

## NUR 012 - Nursing Transition: Advanced Placement Status - 1 credit:

Prerequisite: Advanced Placement students must meet admission criteria established by the department.

This is a mandatory pre-requisite course required of all students granted advanced placement, prior to starting NUR-123, Basic Medical/Surgical Nursing. This course is designed to assess readiness and facilitate a smooth transition for the advanced-placement student into CCM's nursing program. Emphasis is placed on the conceptual framework of the CCM Nursing program, use of the nursing process, communication skills, ethical and legal issues, the role of the registered professional nurse, and safe and effective care. Physical assessment, patient safety, dosage calculation and medication administration are also reviewed and evaluated in a simulated laboratory environment.

### NUR 105 - Foundations of Nursing - 1 credit:

This course provides the foundational concepts on which nursing education and practice are built. Students apply basic knowledge of these concepts as they begin to learn the practice of nursing. Historical, sociocultural, ethical, and legal tenets are studied. Students gain an appreciation for the profession of nursing as well as awareness of the responsibility and accountability expected.

## NUR 121 - Fundamentals of Nursing - 6 credits:

This course serves as the foundation for all subsequent nursing courses. The nursing process is introduced with concentration on the assessment of man's basic health needs, which are identified as psychosocial, elimination, rest and activity, safe environment, oxygen, and nutrition. The development and use of fundamental nursing skills and interventions are included. Concepts of clinical decision-making skills are introduced. Learning experiences are planned, using the classroom, campus laboratory and community clinical facilities. Students in Fundamentals of Nursing also take the one-credit course titled "Foundations of Nursing", NUR 105.

## NUR 123 - Basic Medical/Surgical Nursing - 10 credits:

This course focuses on the study of adults with a variety of commonly occurring medical-surgical problems that interfere with the ability to meet basic health needs. Students utilize the nursing process to prioritize and provide appropriate nursing interventions for patients with higher acuity. Students use assessment skills to develop appropriate nursing diagnoses, outcomes and plans of care. Related theory, therapeutic communication skills and nursing care skills are employed in the provision of patient care in clinical facilities. Clinical decision-making skills are further developed.

## NUR 213 - Maternal-Child/ Mental Health Nursing - 10 credits:

The focus of this course shifts from the study of the adult as an individual to that of the family and community. Concentration is placed on the health needs/problems of psychiatric and maternal/child patients. Utilization of the nursing process with special populations to address patient problems is provided across a range of healthcare settings. Knowledge of community, psychiatric, and maternal/child nursing is developed through critical decision-making skills, Evidence Based Practice (EBP) project, case studies and clinical experiences. Selected medical-surgical skills will be reviewed and/or experienced.

## NUR 214 - Advanced Medical/Surgical Nursing - 10 credits:

This course provides students with the opportunity to further develop and apply clinical decision-making skills to patient care. The PERSON approach is utilized to provide care for patients with health problems resulting when the ability to meet one or more health needs is severely compromised. Evaluation of the outcomes of the care provided is a significant focus. Appropriate learning experiences are planned involving patients with multiple acute and chronic problems using the classroom, campus laboratory and various health care facilities.

## NUR 224 - Nursing Colloquium - 1 credit:

This course involves an examination of selected topics and issues that students in the final semester of the professional phase of the Nursing Program will experience as they transition from the role of student nurse to graduate nurse. Topics concerning professional development and preparation for the workplace are addressed. Ethical, legal, and professional issues that impact the practice of the graduate nurse are examined.

## **Technology Requirements**

All nursing courses use CCM's learning management system, Blackboard (Bb). Students will need reliable access to the internet and a device that can connect to the internet to complete these courses successfully. Some courses may have additional technological needs, such as a webcam and a microphone. These requirements and the modalities of course delivery are specified in each course syllabus.

#### **ADMISSION POLICY**

Students who wish to study nursing should apply to County College of Morris and list nursing as their requested major. Upon acceptance into the college, students are placed in the pre-professional phase. Admission to the college as a nursing major is NOT the same as admission to the professional phase. Admission to the professional phase is a separate process as described below.

## Pre-Professional Phase

This phase is for students who are currently enrolled as nursing majors but not yet eligible for admission into the professional (clinical) phase. Students in this phase take the general education and science courses required for the nursing major. They can study full- or part-time. Day, evening, and weekend classes are offered. Summer courses are also available. Successful completion of the pre-professional phase courses does not guarantee admission to the professional phase.

## **Professional Phase**

This phase includes the clinical nursing core courses. To be considered for admission, students must file a PROFESSIONAL PHASE APPLICATION, which is available in the Nursing Department and on the <a href="mailto:nursing webpage">nursing webpage</a>. Students must be accepted for admission to the college before the PROFESSIONAL PHASE APPLICATION can be filed. Day and evening study tracks are currently offered.

## Day and Evening Study Tracks

The day track sequence begins in the Fall Semester. The PROFESSIONAL PHASE APPLICATION must be filed for the day track by March 15<sup>th</sup> in the Nursing Department.

The **evening track sequence** begins in the Spring Semester. The PROFESSIONAL PHASE APPLICATION must be filed for the evening track by **September 15<sup>th</sup>** in the Nursing Department.

Although classes held on campus follow day and evening hours, clinical times vary widely. Flexibility in schedules is necessary due to the clinical requirement of the program. Clinical placements are based on clinical affiliate availability. Clinical times may overlap day and evening schedules. Clinical hours can occur anytime between 6:00 a.m. and 11:30 p.m. Examples of clinical times that may be assigned include 7:00 a.m. to 7:00 p.m., 10:00 a.m. to 10:00 p.m. or 1:00 p.m. to 11:00 p.m. regardless of day or evening track. Some clinical placements may be split over two days, for example, 7:00 a.m. to 1:00 p.m. on two consecutive mornings or 5:00 p.m. to 11:00 p.m. on two consecutive evenings. Students' requests for clinical site placements or changes are not accepted.

In the event of unforeseen circumstances, modifications, or additions to the standard in-person clinical experience, for example, virtual experiences may be necessary. The time and workload of these experiences are commensurate with that of in-person clinical.

## Admission into Professional Phase

Acceptance into the professional phase is competitive. Applicants are ranked according to their grades in six of the pre-professional courses. Point values are assigned to the grades achieved in the four required sciences and two required English courses. These points are totaled to determine the ranking score. The scores of all applicants are compared to determine admission. Science grades are weighted more heavily than English courses. In addition, an applicant's institutional GPA must be 2.5 or higher and grades in all courses must be a "C" or better. Multiple attempts of a course to achieve a grade of "C" or better will reduce a student's ranking score. Transfer grades in the science and English courses will receive a fixed-point value in the ranking system, regardless of the grade achieved in the course. All science courses must be less than seven (7) years old at the time of admission to the professional phase. Students who have taken science courses prior to this seven-year cutoff can prove competency by testing provided by CCM or by retaking the course. Refer to Appendix H and Appendix I for detailed discussions of the professional phase admission criteria.

All students accepted into the professional phase of the program must undergo a Criminal History Background Check (CHBC) and Urine Drug Screening, obtain health clearance, be BLS certified by the American Heart Association, purchase Malpractice insurance and carry personal health insurance that provides coverage for accidents and illness. Clinical clearances are discussed in detail in the Clinical Clearance Requirements Handbook. Additional clearance requirements may be mandated by some clinical sites. There are requisite functional abilities (technical standards - See Appendix C) that must be met for admission, progression, and graduation from the Nursing Program.

Students applying for admission to the Professional Phase of the Nursing Program at CCM must indicate if they have a violation of the CCM Policy on Academic Integrity or the CCM Student Code of Conduct. The Nursing Department reserves the right to verify this information with the Office of Student Development and Enrollment Management. Cases are handled individually, and students may be dismissed from the program.

No transfer credits will be given for NURSING courses taken at other institutions. Students who have failed/withdrawn or not completed nursing courses taken elsewhere must meet with the Chairperson and may be asked to submit additional documentation related to these circumstances.

#### ADVANCED PLACEMENT POLICY

The Nursing Department offers an Advanced Placement track of study in recognition of the prior educational and work experiences that Licensed Practical Nurses (LPNs) have acquired. Students in this track enter the program in the second semester course, Basic Medical-Surgical Nursing (NUR 123).

The Advanced Placement option applies only to LPNs and is compatible with the New Jersey Articulation Model for Nursing Education.

Admission into the Advanced Placement track is competitive and limited by space availability, so applicants are not guaranteed a seat. A student can be admitted to the Advanced Placement track only once.

#### **REQUIREMENTS:**

- An interview with the Advanced Placement Program Advisor.
- Admission to County College of Morris as a matriculated student in the Nursing Major.
- Completion of all general education and science pre-requisites for the nursing program. Grades must be a "C" or better and the science courses cannot be greater than 7 years old. Ranking for entry into the program is based on grades in all pre-requisites and current GPA.
- Institutional GPA 2.5 or greater.
- Completion of the Advanced Placement Application.
- Graduation from an accredited LPN program.
- A current New Jersey LPN license.
- A letter of reference from a nursing professional.
- Graduation from their LPN program within 12 months
  - OR have graduated from an LPN program within 13 and 36 months and been employed as an LPN for a minimum of 1000 hours during the past 12 months
  - OR have graduated from an LPN program more than 36 months ago and been employed as an LPN for a minimum of 2000 hours during the past 24 months.

## AP TRACK PROGRESSION AND COMPLETION

- Accepted students must successfully complete Nursing Transition (NUR 012) prior to entering Basic Medical/Surgical Nursing (NUR 123).
- Students who fail NUR 012 cannot begin NUR 123. They can be placed into Fundamentals of Nursing (NUR 121) and continue the program on the traditional track. Placement into NUR 121 is limited by seat availability. There is no guarantee that the student will have a seat in the current semester. Placement may be in a subsequent semester.
- Students who fail NUR 121 may be reinstated into NUR 121 in a subsequent semester if their course exam average is 67% or greater and they are passing all other course components. Students can be reinstated into the program only one time. Students with an average of less than 67% are not eligible for reinstatement and must exit the program.
- Students who pass NUR 012 will enter NUR 123. They will have six (6) credits

- for NUR 121 placed into escrow. Upon successful completion of NUR 123, the student will receive credit for NUR 121.
- Foundations of Nursing, NUR 105, must be taken as a co-requisite to NUR 123 or NUR 121.
- Students who fail NUR 123 may be reinstated into NUR 123 in a subsequent semester if their course exam average is 67% or greater and they are passing all other course components. Students can be reinstated into the program only one time. Students with an average of less than 67% are not eligible for reinstatement and must exit the program.
- Traditional students who are ineligible for reinstatement can earn their LPN and apply to the program as an Advanced Placement student. Advanced Placement students who are ineligible for reinstatement cannot apply to the traditional track.
- All other requirements for successful program progression and completion are the same as for all students and are outlined in the nursing student handbook.

LPNs who are interested in advanced placement should contact the Program Advisor or the Nursing Department at <a href="MursingDepartment@ccm.edu">NursingDepartment@ccm.edu</a>. Those interested in being admitted to NUR 123 in the evening program (fall start) must submit the Advanced Placement Application by March 15th and those who wish to be admitted to NUR 123 in the day/traditional program (spring start) must submit the form by September 15th.

## **Study Guides**

Study guides, if used by the course, have been designed to assist the student in organizing and correlating the necessary information to master unit objectives. Study guides will be available two days prior to the beginning of the semester, on Blackboard (Bb), the college's learning management system, so that students may progress at their own rate in preparing the information for lecture and precept. Unit outlines and objectives with their corresponding bibliography are also included. Students are responsible for mastering all unit objectives cited on the study guides. Readings are chosen to assist the student in obtaining information, which will be helpful in mastery of unit objectives. Periodical readings are available from the Sherman H. Masten Learning Resource Center. It is advantageous for students to have completed the readings for a particular study guide topic prior to the first lecture on the topic. It is suggested that students "answer" the objectives in writing so that the information obtained may be used for future reference. It is expected that students will come to precepts prepared to discuss the designated topic of the day. Precept topics are listed on the lecture/precept schedule. Precepts are designed to be interactive and a group endeavor with the instructor available as a resource person.

#### Student Lab Guide

A Student Guide to activities taught in the Nursing Lab for each course is available two days prior to the beginning of the semester on Blackboard. The Student Guide presents specific skills criteria the student must demonstrate for successful course completion.

#### **CLINICAL REQUIREMENTS**

It is the responsibility of the student to review all information in the Clinical Clearance Requirements Handbook. Questions regarding clinical clearance requirements can be directed to the Clinical Clearance Coordinator in the Dean's office at <a href="mailto:clinicalclearance@ccm.edu">clinicalclearance@ccm.edu</a> or the Nursing Department at <a href="mailto:NursingDepartment@ccm.edu">NursingDepartment@ccm.edu</a>.

Additional requirements may be imposed by clinical institutions in the event of any unforeseen circumstances. Students will be notified of these requirements as they occur.

## Annual Mandatory Criminal History Background Check (CHBC)

All students in the professional (clinical) phase are required to submit to an **annual** Criminal History Background Check (CHBC) as mandated by the Joint Commission and clinical contracts.

Refer to Appendix D.

All students accepted for reinstatement must have an updated CHBC before they will be permitted to attend clinical. A positive CHBC may result in program dismissal.

## Fingerprinting

Fingerprints may be required by some clinical affiliates. Students are responsible for paying the cost of fingerprinting required for a clinical rotation.

## **Drug Screening**

All students in the professional (clinical) phase are required to undergo drug screenings prior to the start of the first clinical semester and/or as required by the hospital contracts.

All students accepted for reinstatement must have an updated drug screening before they will be permitted to attend clinical. Refer to <u>Appendix D</u>.

#### Medical Insurance

All full-time and part-time nursing students are required to carry personal health insurance that provides coverage for both accident and sickness. The college does not provide for the purchase of health insurance.

Students must sign an Attestation of Health Insurance Coverage Form stating they will retain health insurance coverage for the duration of the program.

#### **Authorization of Medical Release**

Students are required to authorize County College of Morris to release and disclose any and/or all pertinent medical information contained in their health clearance packet to the clinical facility and/or regulating agency that requires this information as a condition of their assignment to the facility.

Students must sign an Authorization for Medical Release Form.

## **Student Malpractice Insurance**

Malpractice Insurance is mandatory for clinical attendance and must be in effect prior to the start of clinical sessions. Professional liability insurance of \$2,000,000 each claim and \$4,000,000 aggregate is required, listing the holder as a Registered Nurse Student.

Initially, students will need to apply for a policy with \$1,000,000 each claim and \$6,000,000 aggregate coverage. Then, after students have an active policy, the student must contact their carrier's customer service representative and request to change their coverage limits to \$2,000,000 to \$4,000,000. A letter from the school can be provided to the student, upon written request by the carrier.

Students with a current active policy of \$1,000,000/\$6,000,000 must change their coverage limits prior to the start of clinical sessions.

## **BLS Requirements**

BLS certification is required for participation in the Clinical Nursing courses (NUR 121, 123, 213 and 214). This certification <u>must</u> be <u>American Heart Association Basic Life Support (BLS)</u>. This course is designed for healthcare professionals and other personnel who need to know how to perform CPR and other basic cardiovascular life support skills in a wide variety of in-facility and prehospital settings.

Please note that certification by the American Red Cross or completion of other CPR courses offered by AHA are **NOT** satisfactory.

Certification is available from various health care partners including <u>Atlantic Health</u> <u>System</u> and <u>RWJBarnabas Health</u>, <u>Inc</u>.

#### **HEALTH CLEARANCE**

Refer to the Clinical Clearance Requirements Handbook for additional information and forms.

Contracts with affiliating hospitals mandate that all students meet health clearance requirements. All nursing students are required to have a complete history and physical examination annually. Specific blood tests and immunizations and blood tests are also required. Students must have health clearance before they will be permitted to go to the hospital. Health clearance must be completed by the due dates to continue in the Nursing Program. Necessary forms and information are available from the Clinical Clearance Coordinator and on the nursing webpage at <a href="https://www.ccm.edu/wp-content/uploads/pdf/nursing/Clinical-Health-Clearance-Forms.pdf">https://www.ccm.edu/wp-content/uploads/pdf/nursing/Clinical-Health-Clearance-Forms.pdf</a>. As students progress from Fundamentals of Nursing through Advanced Medical/Surgical Nursing their health records must be kept current or enforced clinical absence will be mandated.

Medical History and Physical must be documented on the CCM Health Programs Medical History and Physical Examination form.

#### Immunizations and Vaccines

Refer to the Clinical Clearance Requirements Handbook for detailed information regarding immunization requirements, tuberculosis testing and vaccines.

Note to Females of Childbearing Age:

Women who are pregnant or contemplating pregnancy should consult their health care provider regarding the following health clearance requirements.

## **Immunization Requirements**

Measles (Rubeola)
Mumps
Rubella (German Measles)
Tetanus-Diphtheria
Hepatitis B
Varicella (Chicken Pox)

Documentation of immunity must be provided on the CCM Health Programs Immunization Record. Lack of immunity to any of the above may result in program dismissal.

#### **Tuberculosis Test**

All students in the professional (clinical) phase are required to complete tuberculosis testing annually. Documentation must be provided on the CCM Health Annual Tuberculosis Screening form and signed by a licensed health care provider.

#### Influenza Vaccine

All students in the professional (clinical) phase are required to receive the influenza vaccine annually or provide a valid exemption on the HPNS exemption form. Documentation must be provided on the Health Programs Annual Influenza Vaccination form.

#### **COVID Vaccine**

The COVID vaccine is required by some clinical facilities. Exemptions are accepted by most clinical affiliates.

## **Drug & Alcohol Abuse Policy**

The Nursing Program maintains a no tolerance policy regarding substance abuse. The nursing faculty requires that nursing students provide safe, effective, and supportive care in the clinical setting. To fulfill this purpose, nursing students must be free of chemical impairment during participation in any part of the Nursing Program including classroom, laboratory, and clinical settings. Faculty are accountable for taking prompt action as stated below when a student appears to be impaired.

A multiple panel drug screening is now mandatory for all students doing their clinical education at any of the program's clinical affiliates. Failure to submit to the drug screening will result in dismissal from the program. Any questions regarding this policy should be directed to the Clinical Clearance Coordinator for the School of Health Professions and Natural Sciences at <a href="clinicalclearance@ccm.edu">clinicalclearance@ccm.edu</a>. If a student has a positive drug screening result, they will be contacted by the college's Medical Review Officer (MRO) and the appeal process described in the Clinical Clearance Requirements Handbook will be followed.

In the event of behavior deemed inappropriate or suspicious the college reserves the right to refer the student to the Counseling and Wellness Center and will address such behavior through the college's student conduct policy and procedures (<a href="https://www.ccm.edu/academics/academic-policies/#conduct">https://www.ccm.edu/academics/academic-policies/#conduct</a>). In addition, any student who arrives to the clinical setting and appears to be impaired will be immediately removed from the patient care area and referred to the facility's Emergency Department for evaluation. Any cost for additional screening will be incurred by the student. All student conduct policies for campus behavior apply to nursing students both on campus and at clinical (<a href="https://www.ccm.edu/wp-content/uploads/pdf/aboutccm/policies/section2/2.2008-Substance-Abuse-Policy.pdf">https://www.ccm.edu/wp-content/uploads/pdf/aboutccm/policies/section2/2.2008-Substance-Abuse-Policy.pdf</a>).

## Illness, Injury, Pregnancy

A student in the Nursing Program who sustains a serious illness or injury must obtain a statement from his/her health care provider authorizing return to the clinical nursing area and provide to the Clinical Clearance Coordinator. Until such approval from the health care provider is obtained, the student may not return to the clinical area. (Attendance in the clinical area is at the discretion of the healthcare facility.)

A student who is pregnant must be cleared for participation in clinical by their health care provider.

## **Accident Reporting Procedure**

If a student becomes ill or is injured at a clinical facility, the following steps should be followed:

- 1. The student should notify their instructor.
- 2. The instructor will refer the student to the Emergency Department in the hospital in which the student is injured and follow the facility's policy for documentation with the facility
- 3. The student will contact CCM's Department of Public Safety, either in person or by telephone at 973-328-5550, to report the problem as soon as possible.
  - a. Public Safety will complete an incident report, which is necessary for the college records.
  - b. The student will be responsible for filing a claim to cover the cost of the Emergency Department visit.

The student will be personally responsible for payment of any medical expenses incurred.

#### Uniform

Students must purchase a CCM Nursing Uniform.

Students will need to be in uniform the first day they are in the clinical area. The uniform is not to be worn on the college campus unless participating in clinical simulation.

The uniform consists of a white tunic/top and a white lab coat with navy-colored scrub pants. Scrub tops and pants should be a Cherokee Workwear™ style. No jogger style pants are permitted. Pictures and style numbers are provided for reference in the <u>Nursing Student Uniform Guide</u> on the nursing webpage. White shoes, socks and/or stockings are also required.

The lab coat is the only garment students may wear over their uniform. Students will be permitted to wear white crew neck, short sleeve T-shirts under their uniform tops. A closed toe, all white leather (or other material that will retard penetration) shoe is required. Open-backed clogs and high heels are not permitted.

The white tunic/top, white lab coat, and navy-colored pants may be ordered from any of the following uniform suppliers. The uniform suppliers' contact information is provided in the <a href="Nursing Student Uniform Guide">Nursing Student Uniform Guide</a> on the nursing webpage. Students may buy their uniform from another supplier if the items/styles are the same.

#### Name Pins

Students are required to have two name pins. Name pins are required to be worn as part of the CCM Nursing Uniform. Name pins will be engraved with the student's name as provided to the college. One pin must be affixed to the white tunic/top and the other to the lab coat. Two name pins will be provided to students prior to the first day of clinical.

## Professional Appearance

- Piercings are limited to ears (stud earrings) and nose (one pinpoint stud). One simple, plain band ring is acceptable. Excessive or ornate jewelry is prohibited.
- Hair must be neat, clean, and worn off the collar, so it does not hang in the face or over the shoulders. No extreme hair colors or styles are permitted.
- Mustache and beard must be trimmed and neat.
- Religious headwear is permitted, but the full face must be visible.
- Make-up, if used, should be minimal and natural looking.
- Tattoos should be covered where possible. Tattoos that have profanity or are
  offensive to any group of persons must be covered.
- Perfumes or colognes are not to be used.

- Fingernails must be short and well-manicured and natural. Fingernail tips, wraps, acrylics or any other artificial nail or nail ornamentation are **NOT** permitted.
- Students deemed by the instructor to not conform to a professional appearance may be sent home and the clinical day counted as an absence.
- Additional guidelines specific to patient population and clinical setting may be required. Refer to the course faculty and/or syllabus.

## Transportation

It is essential that the student have an independent mode of transportation. The faculty cannot guarantee that students will be assigned to hospitals located along specific bus or train routes. Many students within their hospital group form carpools to reach the same destination. Some hospitals may require a fee for parking.

#### **Individual Student Folders**

Students are required to submit:

- 1. Completed biographical form
- 2. Photocopy of the face sheet from his/her malpractice insurance policy
- 3. Attestation of Health Insurance Coverage Form
- 4. Copy of current American Heart Association Basic Life Support (BLS). Red Cross Basic Life Support is <u>NOT</u> acceptable.
- 5. Consent form for Criminal History Background Check and Urine Drug Screening (Appendix D)
- 6. Signed proof of having read the "Allied Health and Nursing HIPAA Policy" (Appendix E)
- 7. Signed proof of having read the "Student Education Records Release Form" (Appendix F)
- 8. Signed proof of having read the "Nursing Student Handbook"

#### PATIENT CONFIDENTIALITY

Students are required to maintain patient confidentiality at all times by not discussing patient information in public areas, concealing patient records from the public and discarding patient information in appropriate containers.

Students are responsible for complying with HIPAA regulations as outlined in the healthcare agencies in which they practice. All healthcare agencies supply adherence guidelines for HIPAA to their employees, nursing students and other students utilizing their agency. Students also must adhere to the Allied Health and Nursing HIPAA [Health Insurance Portability and Accountability Act of 1996] Policy. Accessing one's own health record using the clinical agency's EMR is considered a violation of HIPAA.

Photographs of any type, including those in non-patient care areas are strictly prohibited.

Students acknowledge this policy by signing the Allied Health and Nursing HIPAA Policy declaration form. Refer to <u>Appendix E</u>.

#### SOCIAL MEDIA POLICY

Social Media refers to social media outlets, platforms, and applications. Social Media includes (and is not limited to) the use of blogs, social networking sites, video sites, online chat rooms and forums. Legally, what is posted on the Internet is discoverable by a court of law even after it has been deleted. Caution must be used to prevent violating patient privacy and confidentiality.

CCM students in the professional phase of the program must adhere to the following guidelines to protect patient privacy and confidentiality:

- 1. Any discussion, posting and/or reference of any kind to the student's clinical experience via social media are strictly prohibited. This includes reference to patients, employees, students, faculty and/or the clinical institution itself.
- 2. Taking of photos, videos, audios and/or other images at the clinical institution, including the grounds of the institution, is strictly prohibited.

Violation of these guidelines can result in immediate and permanent dismissal from the Nursing Program.

#### **ATTENDANCE**

- 1. **LECTURE, PRECEPT & CAMPUS LABORATORY ATTENDANCE:** Regular and prompt attendance at <u>all</u> classes, including lecture, precept and campus lab is expected and recommended.
  - a. Attendance sheets are made available at lectures, precept, and campus laboratory. Proof of attendance is provided by the student signature on the attendance sheet. It is the responsibility of the student to sign-in at lecture, precept, and campus laboratory.
  - b. Signing in for another student is considered a falsification of record and may result in dismissal from the Nursing Program.
  - c. No guests, including children, will be permitted to attend lectures, precept, campus laboratory, or clinical.
- 2. ABSENCE FROM EXAMINATION: If a student is absent from any exam including the Medical Calculations Exam, the student must immediately contact the Team Leader, who will assign a date, time, and location for the make-up exam. The student is NOT allowed to attend lectures, precept, campus lab, or clinical until the missed exam is completed. The make-up exam may be a different format from the original exam but will cover the same material as the missed unit exam. Failure to notify faculty of your absence will result in a "O" for the exam.
- 3. LATENESS TO EXAMINATION POLICY: If a student arrives late for an exam, the student will only have the remainder of the scheduled exam period to complete the exam. No additional time will be granted. If a student arrives late to an exam, they are required to report to the instructor prior to logging in to the exam.
- 4. LABORATORY/CLINICAL ATTENDANCE: The faculty of County College of Morris believes that laboratory/clinical experiences represent a major component of nursing education. Students must attend and be <u>punctual and prepared</u> for all laboratory/clinical practice. A clinical session is considered any session that is scheduled as "clinical" time. This includes sessions scheduled at the clinical facility and/or clinical sessions scheduled in the nursing laboratory.
  - a. A student who is unable to attend clinical at the hospital or on campus must inform their clinical instructor <u>at least</u> 2 hours prior to the beginning of the clinical day. If a student fails to personally notify the clinical instructor prior to an absence from clinical practice, the student will be required to meet with the Team Leader and faculty to provide an explanation. The student must contact the clinical instructor for additional assignment.
  - b. Any student who has any type of injury necessitating the use of ace bandages, slings, splints, casts, canes, crutches, etc., are

required to present a note from their health care provider describing the reason for such appliance and certifying the student's ability to practice in the clinical setting without restrictions. (Attendance in the clinical area is at the discretion of the healthcare facility.)

A student who is pregnant must obtain her health care provider's authorization for attendance in the clinical area.

- c. Preparation for Laboratory/Clinical Practice: It is expected that all students will come prepared for clinical practice. The level of preparation is defined by the course faculty. Any student who is unprepared for laboratory/patient care may be asked to leave the clinical area, this will be counted as an absence, and will be given an unsatisfactory for that week's clinical performance.
- d. <u>Repeated lateness</u> in reporting to the clinical/laboratory may result in a clinical failure.
- e. Students leaving clinical site during clinical hours: Students will not be permitted to leave their clinical site during clinical hours unless the clinical site does not have facilities for purchasing a meal. In facilities where meals are not available for purchase, students choosing to leave the facility during an approved mealtime will need to obtain the clinical professor's approval and sign out/in on a list provided by the professor.

Clinical absences are regarded by all faculty as serious occurrences because students are not able to meet the clinical laboratory objectives of the course. Although a limited number of clinical experiences can be "made up" in each course, there is no guarantee that the make-up experience will result in a satisfactory grade for the clinical portion of that course. Furthermore, a clinical grade will not be issued until all clinical time is completed, including agreed-upon make-ups.

The following are options from which the faculty may choose for the number of absences as indicated:

ONE (1) ABSENCE: The first clinical absence in a course will result in an additional written clinical assignment and/or nursing laboratory assignment that meets the missed objective. An additional assignment does not replace a clinical session. It provides students an opportunity to augment previous knowledge/skills, as it is NOT under the guidance and supervision of a clinical instructor.

**TWO (2) ABSENCES:** Two clinical absences may result in a clinical failure. Documented proof of medical and/or other reasons must be provided. Students must present their case to the course specific faculty team.

If a student is absent for two (2) sessions in a single course, as soon as the second absence occurs, a notice will be sent by the Team Leader indicating that as a result of excessive absences the student has received an unsatisfactory

grade for the clinical portion of the course and will not be allowed to make up the clinical time unless permission for same is granted on appeal. If a student has had extenuating circumstances, which directly caused the excessive clinical absences, the student may appeal the unsatisfactory clinical rating.

If the appeal is not granted, the unsatisfactory rating for the clinical portion of the course shall be entered and, consequently, a failing grade for that course shall also be entered. If the appeal is granted, the faculty committee shall issue to the student a written decision stating the expected objectives and experiences and a time frame for completing make-up requirements. Requirements can include: (a) at least one clinical laboratory session in the clinical agency or, if not feasible, the Nursing Learning Laboratory AND (b) an additional written assignment that equals the number of missed clinical hours.

THREE (3) ABSENCES: Mandatory withdrawal/failure from the nursing course.

## Religious Holiday Class Attendance Statement

County College of Morris has an obligation to reasonably accommodate any student who may be absent from classes or miss scheduled coursework in order to observe religious holidays. CCM does not inhibit or penalize students for exercising their right to religious observance.

It is the student's responsibility to notify the instructor within the first two (2) weeks of the semester/term of the specific dates conflicting with coursework.

#### **SCHOOL CLOSING & TITAN ALERT**

Official weather-related closings will apply to both didactic and clinical courses. The program will follow class delays or cancellations according to the college's procedure.

In the event of a campus closure due to specific issues related to the campus (for example, power outage at the campus, etc.), clinical classes held off campus will **NOT** be canceled. Procedure for this will be covered within the individual course.

## Titan Alert

Titan Alert is the emergency alert system used by CCM to send email, text messages and/or voice phone messages to students, faculty, and staff in the event of an emergency or weather-related closing. #### STUDENT EVALUATION

## 1. Campus Lab Evaluation

- C. Nursing Laboratory

The Nursing Laboratory is used by all Nursing courses for the instruction of skills, faculty supervised hands-on learning activities and simulation experiences. When not in use by faculty, the Nursing Laboratory is open to all nursing students for independent practice. Students are encouraged to utilize the Learning Laboratory for the practice of skills when time and space permit. Appointments are necessary and an electronic attendance log is maintained. A Laboratory Coordinator will be available to answer questions during posted hours. Day and evening hours are available as posted on the nursing lab schedule. Students are expected to avail themselves of the opportunity to practice and learn. Guests are not permitted in the nursing lab.

#### 2. Clinical Evaluation

Each student receives a mid-term and final evaluation based on defined behavioral objectives, which must be mastered. The instructor also provides the student with formative feedback on their clinical performance throughout the clinical rotation. Any unacceptable behaviors will be discussed with the student at the time of the incident and documented on the Faculty Concern Form, which is retained with the student's record. Students are expected to include self-evaluation comments on the evaluation form. The student signature on the evaluation form acknowledges review of the evaluation with the instructor. Student refusal to sign the evaluation does not negate the content of the evaluation.

Students are expected to meet all technical standards. The student is expected to meet the following generic standards in order to achieve <u>Satisfactory ("S")</u> clinical performance. Failure to achieve any <u>one</u> of these standards may result in an <u>Unsatisfactory ("U")</u> clinical grade.

- 1. Evidence of preparation for clinical laboratory
- 2. Achievement of clinical objectives for appropriate course level
- 3. Application of knowledge expected of students at the given course level as observed through written work and/or actual performance
- 4. Prompt reporting of unusual incidents, accidents, etc.
- 5. Punctuality and regular attendance are mandatory
- 6. Achievement of 85% or better in medical calculation examination

- 7. Demonstration of increasing independence and proficiency at course level
- 8. Retention of previously learned behavior and skills
- 9. Demonstrated competency in the skill acquired for the course
- 10. Assessment, reporting, and recording of changes in a patient's condition
- 11. Maintenance of a patient's privacy and confidentiality (refer to <u>Patient</u> Confidentiality page 27)
- 12. Maintenance of patient's wellbeing through appropriate use of protective devices
- 13. Administration of medications observing current principles of safe medication administration
- 14. Use of surgical and medical asepsis
- 15. Completion of clinical assignment in a timely manner
- 16. Completion and submission of written work in a timely manner
- 17. Engaging in activities not related to the clinical assignment during the clinical day, for example, studying for an exam

## The following behaviors could result in dismissal from the Nursing Program:

- 1. Failure to inform instructor of need for assistance and/or unfamiliarity with a required nursing intervention
- 2. Lying, cheating, stealing, or falsification of records
- 3. Failure to report a patient's threats of harm to self or others
- 4. Failure to report a change in patient's condition
- 5. Refusal to care for assigned patients
- 6. Evidence of impaired functioning (including but not limited to alcohol, drugs, sleep deprivation)
- 7. Any incident or behavior on the part of the student which places a patient in physical and/or emotional jeopardy
- 8. Failure to exhibit behavior appropriate to the profession of nursing
- 9. Violation of the HIPAA Policy
- 10. Excessive lateness and/or clinical absences
- 11. Sleeping during clinical education

#### 3. Academic Evaluation

In the academic area of course work, a student must achieve a grade of "C" or higher. Multiple-choice exams are graded electronically, and the computer maintains a record of each individual student's answers. The computer record remains the official record for students' answers for each exam. Specific grading guidelines are indicated in the Syllabus for each course.

In addition to multiple-choice exams, quizzes, which students are not allowed to keep, may be given during precepts. Precepts are smaller classes wherein students participate in group interactions to examine aspects of the current lecture topic.

#### 4. Grades

A = 86 - 100 B = 76 - 85.9 C = 70 - 75.9 F = 69.9 & below

Grades of "D" are not awarded in the Nursing Program. Plus and minus grades are not awarded in the Nursing Program.

## **Grade Appeal Procedure**

Students have the right to appeal a grade assigned by a faculty member. #### 5. Group Tutoring Assistance

Group Tutoring Assistance (GTA) is available to promote the success of our students. GTA consists of scheduled group review sessions with a faculty facilitator. Enrollment is on-going throughout each semester. Student eligibility guidelines for GTA include:

- All Nursing 121 students
- All students who enter Nursing 123, Nursing 213, or Nursing 214 with a course average of < 76%</li>
- All students in any Nursing course who receive a grade of < 76% on a unit exam, or fail a math exam, during the semester
- All students reinstated into their current Nursing course
- All advanced placement students admitted to Nursing 123

Attendance will be taken at GTA sessions. Participation of all eligible students is highly encouraged. Times and locations will be announced at the start of the semester. Contact your advisor if you have questions.

#### PROGRAM PROGRESSION

To progress to the next semester, all courses as well as pre-requisite and co-requisite courses must be completed satisfactorily; this includes NUR 105 and NUR 224. A minimum grade of "C" or higher is required in all courses. A G.P.A. of 2.0 must be maintained to graduate from the program. Failure of any component (skills, math, theory, clinical) of any clinical course requires that the entire course be repeated.

## Student Accountability

Students are expected to meet with their faculty advisor prior to registration for academic counseling and proper course sequence.

#### PROGRAM INTERRUPTION

#### Withdrawal

If withdrawal is necessary, the student must:

- 1. Complete a withdrawal form and submit it to the registrar by the withdrawal due date specified on the college calendar.
  - Timely submission of the withdrawal form to the Registrar is the responsibility of the student. After the official withdrawal date, an automatic "F" will be recorded for the course.
- 2. Meet with their faculty advisor for an exit interview and complete an exit interview form. A student who withdraws citing \*extenuating circumstances must submit documentation from the appropriate agency or office that attests to the necessity of the withdrawal.

## **Failure**

A student who fails a course must meet with their faculty advisor for an exit interview and complete an exit interview form. A student who fails citing \*extenuating circumstances must submit documentation from the appropriate agency or office that attests to the reason for failure.

#### PROGRAM REINSTATEMENT

Students may seek reinstatement into the Nursing Program according to the following guidelines:

### Guidelines

- A student who has not been reinstated into the program previously may submit an application for reinstatement.
- A student who failed or withdrew from NUR 121 or NUR 123 with an average less than 67, may **not** submit an application for reinstatement.
- A student who failed or withdrew citing \*extenuating circumstances must submit documentation from the appropriate agency or office that verifies the resolution of the extenuating circumstance with the application for reinstatement.
- If more than 24 months have elapsed since the student's last successfully completed nursing course, the student must consult the chairperson regarding reinstatement.
- The application for reinstatement and, if required, supporting documentation, must be received by May 20 for the fall semester and by December 20 for the spring semester. Applications are available from the Nursing Department or at <a href="https://www.ccm.edu/wp-content/uploads/2023/12/Nursing-Reinstatement-Application.pdf">https://www.ccm.edu/wp-content/uploads/2023/12/Nursing-Reinstatement-Application.pdf</a>
- Sciences must be less than 7 years old at the time of reinstatement into the program.

\*Extenuating circumstance is an event related to the student's physical health, mental health, or any external occurrence outside the control of the individual, and specific to that individual.

#### Procedure

The offer of a reinstatement seat is dependent upon space availability in the requested course. Seats are allocated to students requesting reinstatement as follows:

- 1. First time in a course. Students who interrupt their progression to the next course after successful completion of a nursing course but have not been previously granted a seat in the succeeding course.
- 2. Students who were passing the course at the time of withdrawal.
- 3. Students who were failing the course at the time of withdrawal or at end of course completion.

#### Notification

- 1. If accepted, applicants will be informed via student email and receive instructions regarding the documentation required to complete the reinstatement process. A reinstated student will be assigned a clinical section based on space availability.
- 2. If not accepted, the student will be notified by student email. If the student is still interested in being reinstated, they must complete another reinstatement application.

#### STUDENT REPRESENTATION IN FACULTY MEETINGS

Students in each nursing course are provided with an opportunity to be represented in faculty meetings.

- Students are encouraged to elect at least two representatives from their class to serve as spokespersons for the entire class.
- Student representatives are invited to attend a portion of the weekly team meetings.
- Student representatives may attend the meeting in person and/or send their concerns/issues to the Team Leader prior to the Team Meeting.
- Student representatives are encouraged to utilize Bb as a vehicle for communicating pertinent information from Team Meeting to classmates.
- At the discretion of the faculty, students are only permitted to participate in discussions deemed appropriate to the student's involvement.
- Student Nurses Association members are also encouraged to send 2-3 representatives to attend monthly department faculty meetings.

#### COLLEGE STATEMENT ON ACADEMIC INTEGRITY

#### NURSING DEPARTMENT STATEMENT ON ACADEMIC INTEGRITY

Academic integrity is **always** in effect in this program. It is expected that all papers, exams, quizzes, and laboratory assignments submitted by each student reflect their own work, and that they did not give or receive unauthorized aid in any of this work. Students may not collaborate in the preparation of assignments, papers, laboratory assignments, or examinations without the expressed permission of the instructor. Submission or sharing of work previously submitted for a prior course is not permitted and is considered a violation of academic integrity.

Violation of academic integrity or academic dishonesty on a nursing assessment (exam or graded assignment), will result in a grade of **zero** on the assessment. The student will be required to meet with the team faculty to discuss the incident. Additional consequences can include failure of the course and program dismissal. Faculty may choose to submit a formal complaint to the office of the Dean of Students and the Academic Integrity Review (AIR) Board. Students should ask questions from the instructor if they want to clarify exactly what may constitute a violation of academic integrity in their course.

Exams and quizzes (hard copy, computerized, on-line) may not be printed, downloaded, or emailed, as this is a form of academic dishonesty. During exams students may not leave the Blackboard exam tab.

Cell phones and any other electronic devices must be turned off prior to any exam, quiz, or exam review, as this is a form of academic dishonesty. In addition, after a student has finished an exam, the copying or rewriting of an exam question anytime in the future, with or without its answer is considered a breach in academic integrity. Copying and rewriting test questions and corresponding answers electronically via email, chat rooms, Facebook or any other social media sites, iPhones, or any other electronic device is a form of dishonesty. Students found to be involved in unauthorized sharing of test information risk a formal complaint about their behavior being brought to the Academic Integrity Review Board.

Use of, or attempted access of unauthorized materials, such as instructor resources, and misrepresentation of self, other than as a nursing student, is a form of academic dishonesty. Students should ask the instructor if they want to clarify exactly what may constitute academic dishonesty in their course.

#### STUDENT CODE OF CONDUCT & APPEAL PROCEDURE

Students are expected to adhere to the college's code of conduct when engaged in any College-related activity on and off the campus. Students are also expected to adhere to their specific professional codes of conduct (refer to <u>Appendix B</u> with student code of conduct) and those imposed by the clinical institutions.

All student conduct policies for campus behavior apply to nursing students both on campus and at clinical.

#### **Complaint Procedure**

Student concerns should initially be discussed with their assigned nursing advisor. If these concerns are not resolved, students should follow the department's formal lines of communication for filing complaints.

The formal lines of communication for the Department of Nursing are as follows:

- 1. Assigned Nursing Advisor (or when appropriate, clinical instructor)
- 2. Team Leaders
- 3. Nursing Department Chairperson
- Dean of the School of Health Professions & Natural Sciences

The comprehensive and complete Student Code of Conduct and Disciplinary Appeals Procedures may be obtained from the Office of the Dean of Students.

#### **INSTRUCTOR'S & CLASSROOM CONDUCT POLICIES**

Students violating these policies may be subject to disciplinary action.

- 1. Use of Recording Devices. Students are allowed to bring their own recording devices to lecture. There should be no recording without the expressed permission of the person or persons being recorded. These recordings may be used for personal academic use only. Posting of recordings on any public media platform is prohibited. Unattended recording devices will be removed.
- 2. *Use of Cell Phones*: Cell phones must be turned to vibrate in class. No texting is allowed during class. Cell phones must be off during exams.
- 3. Use of Laptops & Other Electronic Devices: Laptops used during lectures are to be utilized for class purposes only. Laptops must be powered by battery. No power cords are allowed in class. Students violating these rules may be asked to leave class.
- 4. *Guests:* No guests, including children, will be permitted to attend lectures, precept, campus laboratory or clinical.
- 5. *Tardiness*: Students arriving late to class may be asked to leave class by the instructor.

#### **Accessibility Accommodations**

In accordance with the policies underlying Section 504 of the Rehabilitation Act of 1973, the American with Disabilities Act (ADA) of 1990, the ADA Amended Acts (ADAA) of 2008 and County College of Morris policy, no qualified individual with a disability shall, solely on the basis of that disability, be excluded from participation to County College of Morris programs or activities. Students may seek reasonable accommodations for their documented disability by self-identifying and registering with the Office of Accessibility Services. It is the student's responsibility to ensure adequate time is provided to the Office of Accessibility to arrange accommodations and notify faculty. ## ATTENDANCE POLICY FOR STUDENT NURSES ATTENDING STUDENT NURSES CONVENTION

Opportunities are available for students to attend Student Nurses Convention.

- 1. A student who wishes to attend a student nurses' convention must have satisfactory performance both academically and clinically.
- 2. Students attending the convention must be active members of the Student Nurses Association and the New Jersey Student Nurses Association.
- 3. The Student Nurses Association will submit a list of students wishing to attend the convention to the faculty advisor.
- 4. A list of the students wishing to attend the convention will be given to the Team Leaders. The faculty advisor will consult with the Team Leaders regarding the student's eligibility to attend the convention.
- 5. The Department Chairperson will submit the list of students eligible to attend the convention to the Office of Campus Life before any tickets or other arrangements are initiated.
- 6. Students who attend the convention must make a presentation to either their class or the Student Nurses Association on seminar content and what they learned after they return from the convention.

#### REGISTRATION

Students need to be aware that there is no guarantee that they will be able to register for their desired clinical sections/or clinical hours. There is also no guarantee that their assigned clinical facility will be near their home/residence.

Although classes held on campus follow day and evening hours, clinical times vary widely. Flexibility in employment and personal commitment schedules is necessary

due to the clinical requirement of the program. Clinical placements are based on clinical affiliate availability. Clinical times may overlap day and evening schedules. Examples of clinical times that may be assigned included 10:00 a.m. to 10:00 p.m. or 1:00 p.m. to 11:00 p.m. regardless of day or evening track.

Reinstated students may not register until they are informed in writing that they have been reinstated. They will be advised when to register. Students may not be allowed to attend the same hospital for Basic Medical/Surgical Nursing and Advanced Medical/Surgical Nursing.

#### GRADUATION INFORMATION

#### **Graduation Requirements**

It is the <u>student's responsibility</u> to check the college Catalog regarding requirements for graduation. To be eligible for graduation, a student must meet the application deadline posted by the Registrar's Office.

#### Additional Fees

#### RN Licensure

Fees associated with the Official Application for Nurse Licensure by Examination total approximately \$500.00. This includes the examination application filing fee, license certificate fee, surcharge, and test application.

#### **NCLEX Review Course**

Although not mandatory, many students enroll in an NCLEX Review Course prior to taking the NCLEX-RN exam. Fees for these courses vary, but generally range from \$350.00 - \$500.00.

The HESI Exit Exam, completed by all students in NUR 214, provides individualized remediation packets that can be used for NCLEX-RN preparation.

#### Pinning

The senior nursing students plan a pinning ceremony as part of graduation. The pinning committee must meet with the faculty advisor in planning this ceremony.

Approval of all activities must be obtained from the faculty advisor and the chairperson.

#### New Jersey Board of Nursing Requirements

The Nurse Practice Act of the State of New Jersey Board of Nursing Statutes (NJSA 45:11-23 et seq.) and Regulations (N.J.A.C. 13:37) govern the legal practice of Nursing in the state. Details regarding the statutes can be found at <a href="https://www.njconsumeraffairs.gov/Statutes/nursing-law.pdf">https://www.njconsumeraffairs.gov/Statutes/nursing-law.pdf</a>. Applicants to the Nursing Program need to be aware that the New Jersey Board of Nursing requires the following criteria be met before an individual may receive an application for a license to practice professional nursing.

"The applicant must submit to the board evidence in such form as the board may prescribe that the applicant

- 1. has attained his or her eighteenth birthday.
- is of good moral character, is not a habitual user of drugs and has never been convicted or has not pleaded nolo contendere, non vult contendere or non vult to an indictment, information or complaint alleging a violation of any Federal or State law relating to narcotic drugs.
- 3. holds a diploma from an accredited four-year high school or the equivalent thereof as determined by the New Jersey State Department of Education.
- 4. has completed a course of professional nursing study in an accredited school of professional nursing as defined by the board and holds a diploma therefrom."

Graduates of the County College of Morris Associate Degree Nursing Program are eligible to apply for the National Council Licensure Examination (NCLEX-RN). This examination is offered throughout the United States during the calendar year. Upon satisfactory completion of this examination, the applicant shall be licensed by the New Jersey Board of Nursing to practice as a registered professional nurse.

When a graduate applies for licensure as a nurse in New Jersey, the New Jersey Board of Nursing requires a Criminal History Background Check. If the Criminal History Background Check reveals a criminal conviction, a review of the application by the Board of Nursing is required.

#### Transfer/Articulation/RN to BSN

Students who plan to continue their education beyond the Associate Degree are encouraged to use the resources available in the Office of Transfer Services. Currently we have partnerships with Saint Elizabeth University (formerly College of St. Elizabeth), Rutgers University, Ramapo College of New Jersey, Drexel University, Thomas Edison State University, William Paterson University and Montclair State

University. These enable students to go on to complete their BSN. Additional information is also available in the Nursing Department.

#### ADDITIONAL INFORMATION

#### **Student Nurses' Association**

County College of Morris has an active Student Nurses' Association. All students designated as nursing majors (pre-professional and professional phase) are automatically listed as members, but the club is open to all students. The club selects a slate of officers who plan a variety of activities throughout the year with the help of their faculty advisor. Student member participation in the club events is voluntary.

The minimum standards for membership are:

- Grade of B or better in all nursing courses
- No previous failures of any nursing courses

Students entering their third semester nursing course and who meet the minimum eligibility requirements noted above, will be granted provisional membership. Full membership is granted at the completion of the final semester of study if the student earns a grade of B or better in all courses. Students must also have demonstrated conduct on campus and in the clinical areas that reflect integrity and professionalism.

Faculty members may be asked to write personal references for students. The student must submit a completed FERPA form (see <u>Appendix G</u>) to the faculty member before the letter can be written. Allow adequate time (at least twenty-one days) for the faculty member to send the letter.

#### **Student Professional Activities**

The nursing faculty strongly advises the student to join the National Student Nurses Association and to subscribe to a professional journal.

#### **Transcript Requests**

Information about a student can be released only with the written permission of that student.

All transcript requests must be sent to the Registrar's Office.

#### **Nursing Communication**

A bulletin board, for each core nursing course, is located outside the Nursing Laboratory.

Information is also communicated using the nursing webpage, Blackboard, student emails and other bulletin boards throughout the lab areas.

Due to continual program revisions mandated by accrediting agencies and/or changes in state mandated requirements, students should consult their academic advisor when selecting courses.

Students need to be aware that due to the competitive nature of admission into the Nursing Program, granting a seat into the professional (clinical) phase is based on Science and English grades and the overall institutional grade point average. Preference is given to students who take their Science and English classes at CCM. Admission into the professional (clinical) phase is not guaranteed once prerequisites are completed. Please see the Nursing Department website (www.ccm.edu/academics/divdep/health-professions-natural-sciences/department-of-nursing/) for more information regarding transfer students and professional phase admission.

All science courses must be completed (or in progress) at the time the professional phase application is submitted. The professional phase application cannot be filed until the student has been accepted for admission to the college. Students must have an institutional GPA of 2.5 or higher to apply for the professional phase of the program. Students required to take remedial course work will take longer to complete the program.

All grades must be "C" or better. Science courses completed by students prior to entering the program must be less than seven years old. If the science courses exceed the seven-year limit, students must prove their competency by testing, or they must retake the courses.

Upon acceptance into the professional phase of the Nursing Program, students will be subject to a drug screening and an annual Federal and State criminal background check. A positive criminal background check may result in denial into or continuance in the program. Students must maintain personal health insurance. Students should refer to the Clinical Clearance Requirements Handbook for more information.

#### Appendix C

## County College of Morris Department of Nursing

#### **TECHNICAL STANDARDS**

In accordance with the policies underlying Section 504 of the Rehabilitation Act of 1973, the American with Disabilities Act (ADA) of 1990, the ADA Amended Acts (ADAA) of 2008 and County College of Morris policy, no qualified individual with a disability shall, solely based on that disability, be excluded from participation to County College of Morris programs or activities. Upon admission, a candidate who discloses a disability may be asked to provide documentation of that disability. The Department of Nursing at the County College of Morris will provide reasonable accommodations to a qualified individual with a disability through support of the Office of Accessibility Services. County College of Morris is not required to provide academic adjustments that would lower academic standards, fundamentally alter the nature of the program or impose an undue burden on the college. Students can provide appropriate documentation to the Office of Accessibility Services directly to qualify for reasonable accommodations. Reasonable accommodations for the academic environment and the clinical environment are administered through two separate and distinct processes in collaboration with the Office of Accessibility Services, the Nursing Department, and the individual student.

The goal of the Department of Nursing at the County College of Morris is to prepare students to think critically and practice nursing competently and compassionately in any environment where individuals, families, and communities need care, information, or advocacy. All efforts are designed to build relevant nursing knowledge, ensure patient safety, foster professional integrity, and ultimately improve the health outcomes of patients, families, and communities across the continuum of care. To achieve these goals, certain functional abilities (technical standards) are essential for the delivery of safe, effective nursing care during clinical training activities and in broad entry-level practice upon graduation. Therefore, it has been determined that these are required for acceptance into, progression through, and graduation from the Nursing Program. Students are expected to request reasonable accommodations prior to beginning the professional (clinical) portion of the program. Successful completion of skills testing, and all clinical experiences is required to graduate from Nursing Program at the County College of Morris.

An individual must meet, with or without reasonable accommodation, the following technical standards:

<u>General Abilities</u>: The student is expected to possess functional use of the senses of vision, touch, hearing, and smell so that data received by the senses may be integrated, analyzed, and synthesized in a consistent and accurate manner, during physical assessment and patient interactions.

<u>Communication Ability:</u> The student must have the ability to read, write, comprehend, and speak the English language to facilitate communication with patients, their family members, and other members of the healthcare team in healthcare settings. The student must be able to communicate effectively both verbally and in writing with instructors and other students in the classroom setting.

<u>Motor & Mobility:</u> The student must have the capacity to perform gross and fine motor movements sufficient to provide safe and effective nursing care. The student must have physical abilities sufficient to administer physical care to patients in different settings. The student also must have physical abilities sufficient for movement from room to room and in small spaces.

<u>Cognitive Ability:</u> The student must be able to measure, calculate reason, analyze, integrate, and synthesize information obtained in the classroom and clinical setting. They must be able to engage in critical thinking in the classroom and clinical setting.

<u>Behavioral and Social Attributes:</u> The student must have the ability to function effectively under stress and to adapt to an environment that may change rapidly. The student must be able to accept the role of a student nurse functioning under supervision of a clinical instructor or preceptor in the clinical setting. The student must be able to demonstrate interpersonal skills sufficient for professional interactions with a diverse population of individuals, families, and groups.

Subject: Criminal History Background Check and Urine Drug Screening

I acknowledge that I have received written notification informing me that all students in clinical sections will be required to submit to a Criminal History Background Check and Urine Drug Screening as mandated by the Joint Commission and Clinical Affiliate Contractual Guidelines. These Criminal History Background Checks will occur on an annual basis. If the background check yields a positive result, admission into the professional phase of the program may be denied. If at any time after acceptance into the professional phase of the program a student has a positive criminal history background record, it may result in dismissal from the program.

All students accepted for reinstatement must have an updated Criminal History Background Check before they will be permitted to attend clinical.

When a graduate applies for licensure as a nurse in New Jersey, the New Jersey Board of Nursing requires a Criminal History Background Check. If the Criminal History Background Check reveals a criminal conviction, a review of the application by the Board of Nursing is required.

Any student who violates PHI or HIPAA privacy or non-disclosure requirements will be dismissed from the Allied Health or Nursing Program. The student may appeal the decision to the Dean of the Division of Health and Natural Sciences and the Senior Vice President of Academic Affairs, Workforce Development, and Student Success. The Senior Vice President of Academic Affairs, Workforce Development, and Student Success decision is final. The student is not eligible to reapply to either the Allied Health or Nursing Program.

#### NURSING DEPARTMENT: ADMISSION TO THE PROFESSIONAL (CLINICAL) PHASE

- Completion of prerequisites does not guarantee admittance into the professional phase.
- Admission to the professional phase is competitive and based on a ranking system.
- Ranking points are only assigned to grades in English Composition I and II and the four required sciences: Introduction to Chemistry or General Chemistry I; lab not required, Anatomy and Physiology I and II with lab, and Microbiology with lab. Ranked science courses MUST be seven years or less old at the time of admission to the professional phase.
- Students who earn a D or F, or withdrew from the course, prior to receiving the passing grade will receive a deduction in ranking points.
- Transfer credits receive a fixed-point value in the ranking system regardless of the grade received in the course. Refer to the "<u>Transfer Information for Nursing Students</u>" document for more information.
- Students with a previous college degree (Associate or higher) are given additional ranking points. Please be sure the transcript on file at CCM shows your conferred degree.
- Students who failed or did not complete nursing courses taken elsewhere must provide
  documentation with their application that explains this occurrence. Students must have been in
  "good standing" in their previous program and confirmation from the prior program director or
  program representative may be requested.
- Students who have attended CCM must have an institutional GPA of a 2.5 or greater.
- Transfer credits are not included in the institutional (CCM) GPA.
- Transfer students who are interested in the Nursing Program at CCM and still need to take the
  required science or English courses are highly encouraged to take these at CCM.
   Students who complete their prerequisites at CCM receive priority consideration for admission
  to the professional phase.
- The application for the day study track for the professional (clinical) phase is due in the Nursing Department by March 15<sup>th</sup> for a fall semester start.
- The application for the evening study track for the professional (clinical) phase is due in the Nursing Department by **September 15**<sup>th</sup> for a spring semester start.
- You CAN apply for the professional phase with your final prerequisites in progress. Spring Semester grades will be included in the ranking points for the March 15<sup>th</sup> applicants but Fall Semester grades are not available at the time of ranking and so cannot be included in the ranking points for the September 15<sup>th</sup> applicant. If a conditional acceptance is given with ranked courses in progress, the student must successfully complete the course with a "C" or higher to keep their seat in the professional phase.

## NURSING DEPARTMENT INFORMATION FOR TRANSFER STUDENTS TO THE NURSING PROGRAM

County College of Morris accepts transfer credits for prerequisite courses from other institutions toward the Associate in Applied Science, Nursing Degree, however students who complete prerequisites at CCM receive priority consideration for admission. Admission to the professional phase is competitive and determined by a point ranking system. Transfer courses receive a fixed-point value of 5 points for English courses and 10 points for science courses. There is no point differential for grades earned in transfer courses. Therefore, when all prerequisites are transfer credits, achieving a competitive ranking score is unlikely.

#### Checklist for Transfer Students:

- 1. Submit your application for admission to the college (online or in person) and specify Nursing as the intended major. If you have previously taken classes here as a visiting student, please complete the "Request to Matriculate" form.
- 2. All previous college transcripts should be sent to Admissions for review of eligible transfer credits. Please note: The Nursing Department does not evaluate transcripts.
- 3. Please check your student program evaluation on <u>Titans Direct</u> to confirm the granting of transfer credits. For help using Titans Direct, <u>click here</u>.
- **4.** Competency in Math, English and Technology is evaluated to determine correct course placement. Guidelines for this process can be found at <u>Planning Tools & Course Information County College of Morris (CCM)</u> **Prerequisite Courses Eligible for Transfer**


English Composition I:	3 credits
English Composition II:	3 credits
General Psychology:	3 credits
Health and Wellness Electives (can include CPR):	2 credits
Social Science or Humanities General Education course:	3 credits
*Anatomy and Physiology I:	4 credits
*Anatomy and Physiology II:	4 credits
*Introduction to Chemistry or General Chemistry I:	3 credits
*Microbiology:	4 credits

\*The science courses must be seven (7) years or less old at the time of admission to the professional phase of the Nursing Program.

Clinical nursing courses from other institutions are not accepted for transfer. Students who failed or did not complete nursing courses taken elsewhere must provide documentation with their application that explains this occurrence. Students must have been in "good standing" in their previous program and confirmation from the prior program director or program representative may be requested.

Students with a previous college degree (Associate or higher) are given additional ranking points. Please be sure the transcript on file at CCM shows your conferred degree.
