Transfer applicants to the West Virginia University (WVU) College of Creative Arts (CCA) School of Art and Design (SOAD) must undergo a portfolio review to gain admittance in the program. Evaluation for advanced standing or transfer credit in studio subjects is not made solely upon the presentation of a transcript but also depends on the evaluation of a portfolio of artwork. Students are required to submit also submit portfolio of work completed in the following courses:

- ART 219; 223; 224; 228; 241

*Portfolio review is encouraged for ART 131 and 230. Upon successful review, student will be awarded credit for ART 293 at WVU which will complete 6 hours of the eighteen (18) required hours of ART/ARHS 200+ level electives. Students who do not receive this credit will need to utilize elective credit to complete this requirement for the BFA degree and need to work with their WVU CCA SOAD advisor to schedule courses for the most appropriate time.

Students are encouraged to submit portfolios for review at the end of each respective course, and not simply at the time of transfer.

Per WVU CCA SOAD requirements, students must receive a grade of **C-** or better in the following courses:

- ART 133 & 134

Per WVU CCA SOAD requirements, students must receive a grade of **B-** or better in the following courses:

- ART 122; 123; 124; 130; 132;

**The WVU CCA School of Art and Design limits the number of studio hours allowed per semester to nine (9). Three (3) of these hours may be studio art electives. Any additional ART elective courses must be non-studio based courses.

Students transferring into the WVU CCA School of Art and Design are encouraged to submit a portfolio of written assignments to be reviewed for completion of the school's writing requirement. Students who do not submit a portfolio, or whose portfolio is found insufficient, will be required to complete a "Writing Intensive" course while at WVU.

The WVU General Education Foundations curriculum (GEF) includes eight areas (F1-F8). F1 (Composition and Rhetoric), F2 (Science & Technology), and F3 (Mathematics & Quantitative Skills) are specified above. These 3 Areas will be fulfilled by General Education requirements at County College of Morris and ENGL 102 at WVU. Students must also complete 3 credit hours from each of the GEF Areas 4 through 7. GEF 4 & 6 will be fulfilled upon successful completion of SOC 120/PSY 113 and ART 133 respectively. GEF 5 & 7 will be completed at WVU.

The WVU GEF curriculum also includes 9 credits (normally 3 three-credit courses) of Focus coursework (F8), to help students capitalize on the range and diversity of courses offered at WVU. In order to maximize connections, incorporate additional competencies, and encourage true breadth of study, students must fulfill the Focus through completion of one of the following academic paths: (a) completion of a minor; (b) completion of a double major or dual degree, or (c) completion of 9 credits of additional coursework from the list of courses approved for GEF Areas F1 through F7. County College of Morris students following this pathway will complete six (6) of the F8 required hours with successful completion of ART 134 and COM 109. The final three (3) hours can be completed with either ARHS 382 or 388 at WVU. Students who wish to take an ARHS 200+ level elective other than these 2 courses will exceed the 120 credit hour minimum for the BFA degree and need to work with their WVU CCA SOAD advisor to schedule courses for the most appropriate time.
