To make it easier for planning, below are the dates for the café style meetings that are open to all employees:



IMPORTANT INFORMATION FOR NJ PERS MEMBERS

P.L. 2019, c. 157 (Chapter 157), the Bill Ricci World Trade Center Rescue, Recovery, and Cleanup Operations Act, permits an active member of the PFRS, the SPRS, and PERS Law Enforcement Officers (LEOs) or Emergency Medical Technicians (EMTs) to file for an Accidental Disability Retirement if the member is or is to become totally and permanently disabled due to participation in a rescue, recovery or cleanup operations at the World Trade Center between September 11, 2001, and October 11, 2001, regardless of whether the member was enrolled in the PFRS, SPRS or PERS at the time of participation or under orders or instruction by an employer to participate.
