TUITION WAIVERS FOR EMPLOYEES AND THEIR FAMILIES

CCM employees may be eligible to take advantage of a tuition waiver benefit to enroll in classes at the college. In most cases, that benefit also is offered to the employee's spouse and dependent children (age restrictions apply). The benefit waives the cost of tuition only and does not cover college and course fees. For specifics regarding waiting periods, eligibility and the number of college credits that can be taken at a given time, refer to your bargaining unit contract or Board of Trustees Policy Manual.

To take a credit course:

- Apply through the Admissions office
- Fill out the Tuition Waiver Form and obtain all required signatures. The form can be found under E-forms in the Faculty/Staff section of the CCM website.
- Register for the class at Records and Registration.
- Bring the completed Tuition Waiver Form to the Bursar office to pay any college and/or course fees that are due.

To take a non-credit course:

- Fill out the Tuition Waiver Form and obtain all required signatures. The form can be found under E-forms in the Faculty/Staff section of the CCM website.
- Register for the class at the Records and Registration.
- Bring the completed Tuition Waiver Form to the Bursar office to pay any college and/or course fees that are due.

Employees who enroll for classes should use their employee login information to access Titan's Direct and Blackboard.

The webinar will address how balancing the interests and concerns of all impacted individuals – students with disabilities, instructors, other students, parents and others – is becoming increasingly challenging, while presenting a number of scenarios and how they can be resolved. Issues to be addressed include how institutions need to ensure that their processes are conducted in good faith and that their policies and procedures do not inappropriately treat students with disabilities differently, deny them due process or fail to safeguard their academic wellbeing.

IMPORTANT PERS ELECTION NOTICE

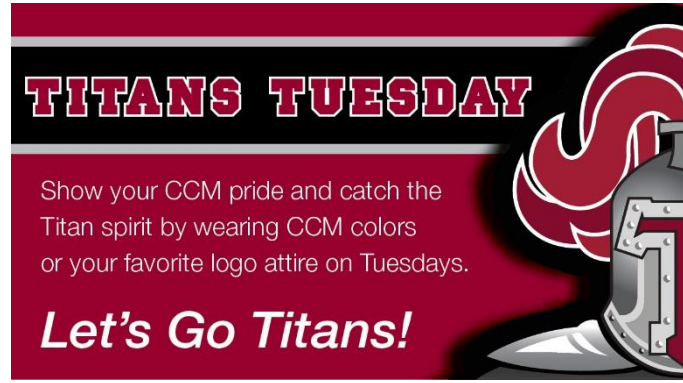
Please be advised that the current PERS-County position on the Board expires on June 30 and the seat is at risk of becoming vacant. The process to fill this seat began in October 2019. Currently eight nominees have expressed interest in this position. However, to date, no nominee has obtained the requisite 500 nominations to proceed to an election.

Because none of the nominees has obtained the requisite number of nominations, and to avoid PERS-County members from losing full representation on the board, the NJDPB has extended the nomination period from January 30 to Friday, February 28, at 4 p.m.
