Satisfactory Academic Progress Regulation Summary

All Federal, NJ State, CCM scholarship and a few private student loan lenders financial aid recipients are subject to a Satisfactory
Academic Progress (SAP) evaluation at the end of each academic year.

That evaluation will determine continued eligibility for financial aid assistance.

As is required by the <u>U.S. Department of Education</u>, satisfactory academic progress (SAP) must be maintained toward completion of degree, therefore student's progress is evaluated annually by County College of Morris, adhering to the federal requirement for continued financial aid eligibility determination. In order to make "Satisfactory Academic Progress" a student must maintain a minimum <u>cumulative</u> grade point average and earn a minimum number of credits (percent) each academic year (*see chart below). Students who did not meet these requirements academically will be INELIGIBLE for financial aid assistance. Those affected students are given the opportunity to **appeal (supporting documented proof is required) to the Office of Financial Aid for aid reinstatement. Reinstated aid eligibility may be on a ***Probationary basis (see below for conditions).

1. You are in good academic standing, after having attempted the first (12) College-level credits, your Cumulative Grade Point Average (GPA) falls within the following categories:

REPEATS

<u>Repeated</u> courses and courses with "I", "W" and "F" grades will be included in credits attempted, but not earned. Credits by examination will be counted as credits attempted earned. Grades received at other institutions or from prior programs at CCM will not be used in computing the cumulative grade point average at CCM. Audited classes are not included toward Satisfactory Academic Progress.

2. **You are **making Satisfactory Academic Progress** (SAP) if your total number of credits is at or above the following level as measured by a percentage of the credits attempted each academic year. Students are allowed to attempt up to 150% of their program to complete their degree.

Example: If your program requires 60 credits to graduate, you will have 90 credits in which to complete your program based on the number of credit hours attempted. Thus, you should be successfully completing at least 67% of your classes each year.

REVIEW OF RECORDS

The review of academic records takes place at the conclusion of the spring term for the following award year. The review covers your cumulative record including summer semesters. We understand that you may have a difficult semester and therefore do not review your record until the end of the spring term allowing you a full academic year to make academic progress.

AUDIT COURSES

There is no financial aid assistance available for courses audited.

CREDITS TAKEN AT OTHER INSTITUTIONS

Credits transferred from another institution will be counted toward maximum time frame of completion and will be calculated as earned credits, but will not be calculated as part of your GPA.

CREDITS FROM PRIOR CCM PROGRAMS

Credits earned from a previous program at CCM that apply toward your current curriculum will be calculated toward maximum time frame of completion of your current curriculum and will be calculated as earned credits, but will not be calculated as part of your GPA.

DEVELOPMENTAL AND ESL COURSE WORK

Students taking developmental and <u>ESL course work are eligible for financial aid for up to 30 non-credit hours</u> as prescribed by the College. Non-credit courses that are successfully completed are included as attempted and earned. Non-credit courses not successfully completed will be included as attempted, but not earned.

**APPEALS/REINSTATEMENTS

Level III

Students who have been notified of financial aid ineligibility due to not making academic progress, have a right to appeal for reinstatement of financial aid in cases of **unusual circumstances** (i.e., death in family, serious illness- medical statement, police report, etc.). A Satisfactory Academic Progress Review Committee will review appeals, which must be submitted in writing and be accompanied by supporting documentation. Once your appeal has been reviewed, a response will be sent to you electronically (CCM student email).

***PROBATION

Students whose appeals have been approved are placed on financial aid eligibility on a **probationary basis** for one year with continued eligibility contingent on the GPA received. During this period the student MUST register for no less than half-time and attain a passing grade of "C" or better or term GPA greater-than or equal to 2.0. Course withdrawals are not permitted during this period as a withdrawal after class has met is treated as an attempted credit, exception being extenuating circumstances, i.e. medical. Failure to do so will result in the suspension of financial aid eligibility (loans included). **Additionally, during the probationary period the term GPA will be monitored for continued financial aid eligibility. It is also strongly suggested that probationary students meet with an academic advisor, establishing an academic plan, ensure success toward graduating.
