BOARD OF TRUSTEES MINUTES
REGULAR MEETING
August 17, 2016

CALL TO ORDER

Board of Trustees Chair Dr. Joseph L. Ricca, Jr. called the regular meeting of the Board of Trustees of the County College of Morris to order at 6:00 p.m., in the Board Room, Henderson Hall. Chair Ricca stated that in compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of this Regular Meeting of the Board of Trustees has been satisfied by the inclusion of the date, and time of this Regular Meeting in the annual notice of regular meetings of the Board. Such annual schedule and notice of regular meetings is posted on the bulletin board outside the President's Office, was mailed to the Daily Record and Star Ledger, and was filed with the Clerk of the County of Morris on November 19, 2015.

ROLL CALL

Trustees Advokat, Bogaard, Giarratano, Jinks, Licitra, Pepe, Tkacs, and Chair Ricca were in attendance. Trustees Hadzima, Van Allen, and Weisberg were absent. Alumni Trustee Saavedra, President Yaw, and Attorney Chait were also in attendance.

ADOPTION OF RESOLUTION TO DISCUSS MATTERS IN CLOSED SESSION

RESOLVED, At the Regular Meeting of the Board of Trustees on August 17, 2016, that pursuant to Sections 7 and 8 of the Open Public Meetings Act, the following subjects be discussed in a session closed to the public at approximately 6:00 p.m., Henderson Hall, Room HH 103.

1. Compensation for Professional Services
2. Employee Retirements and Resignations
3. Reclassification of Evening Custodial Positions
4. Authorization to Recruit for Plant and Maintenance and Athletics Positions
5. New Employee Appointments
6. Collective negotiations and matters involving the attorney-client privilege.

It is anticipated that all of the above items will be disclosed to the public at the reconvened session of the Board at 6:30 p.m. with the exception of Item #6.

Upon the motion of Chair Ricca and the second of Trustee Advokat, Chair Ricca called for discussion by members of the Board. There being no discussion, Chair Ricca called for a voice vote of the Board. The voice vote of the Board indicated that all present were in favor. The meeting was closed to the public at 6:01 p.m. The public meeting reconvened at 7:25 p.m.

PLEDGE OF ALLEGIANCE

Chair Ricca invited everyone to rise and salute the flag. Everyone rose, saluted the flag and recited the Pledge of Allegiance. Following the flag salute the Board of Trustees and others present at the meeting observed a moment of silence.

APPROVAL OF MINUTES

Chair Ricca called for consideration of the minutes of the regular meeting of July 20, 2016, including the closed session. Upon the motion of Trustee Pepe and the second of Trustee Advokat, Chair Ricca called for a voice vote of the Board. The voice vote of the Board indicated that all were in favor; Trustee Jinks abstained from the vote.

REPORT OF THE PRESIDENT

President Yaw referred the Board to the written President's Report that is on file in the Office of the President.

REPORT OF THE TREASURER

Treasurer Bogaard moved for the adoption of the following resolution.

- A. RESOLVED, That the check numbered 0129188 in the amount of \$36,527.99 and 0129237 in the amount of \$73,049.49, be approved and payment authorized for capital improvements.

Trustee Licitra seconded the motion. Chair Ricca called for discussion by members of the Board. There being no questions or comments, Chair Ricca called for a roll call vote of the Board. The roll call vote of the Board indicated that all were in favor. The Report of the Treasurer was concluded.

On behalf of Committee Chair Weisberg, Chair Ricca moved for the adoption of the following resolutions.

- C. WHEREAS, The Personnel Committee has reviewed the rationale to create two full time Evening Custodial positions in the Plant and Maintenance Department, therefore;
- BE IT RESOLVED, That upon the recommendation of the Personnel Committee and the President, the Board authorizes the College to create two full time Evening Custodial positions in the Plant and Maintenance Department; and
- BE IT FURTHER RESOLVED, That six part time Evening Custodian positions be abolished due to the establishment of the two full time positions.
- D. WHEREAS, the Personnel Committee has reviewed the rationale to recruit for the position of Associate Director of Plant & Maintenance, Management, grade 34, in the Plant and Maintenance Department, now therefore;
- BE IT RESOLVED, That upon the recommendation of the Personnel Committee and the President, the Board authorizes the College to recruit for the position of Associate Director of Plant & Maintenance, Management, grade 34, in the Plant and Maintenance Department.
- E. WHEREAS, the Personnel Committee has reviewed the rationale to recruit for the position of Athletics Trainer & Summer Events Coordinator, AAPF, grade 13, in the Athletics Department, now therefore;
- BE IT RESOLVED, That upon the recommendation of the Personnel Committee and the President, the Board authorizes the College to recruit for the position of Athletics Trainer & Summer Events Coordinator, AAPF, grade 13, in the Athletics Department.

Trustee Licitra seconded the motion. Chair Ricca called for discussion by members of the Board. There being no questions or comments, Chair Ricca called for a roll call vote of the Board. The roll call vote of the Board indicated that all were in favor; Trustee Giarratano abstained from the vote.

The roll call vote of the Board indicated that all were in favor. The Report of the Committee on Personnel was concluded.

WHEREAS, Niram, Inc., 4 E. Frederick Place, Cedar Knolls, NJ 07927, submitted a bid in the amount of \$487,000.00, which is the lowest responsible bid received from a qualified bidder for the project; and,

WHEREAS, by correspondence dated August 2, 2016, the architects, the RBA Group, recommended award of the bid to Niram, Inc.;

NOW, THEREFORE, BE IT RESOLVED, on this 17th day of August, by the Board of Trustees of the County College of Morris that Niram Inc. be awarded the contract for Bid #B1617-1JK for the Henderson Hall Window and Door Replacement Project in the amount of \$487,000.00.

- B. WHEREAS, The County College of Morris pursuant to public advertisement, received and opened bids on August 10, 2016 for the Pre-Engineered Metal Storage Building Project under Bid #B1617-2JK; and

WHEREAS, Dobtol Construction LLC, 210 River Street, Suite 21, Hackensack, NJ 07601, submitted a bid in the amount of \$644,000.00, which is the lowest responsible bid received from a qualified bidder for the project; and

WHEREAS, by correspondence dated August 11, 2016, the architects, the RBA Group, recommended award of the bid to Dobtol Construction LLC;

NOW, THEREFORE, BE IT RESOLVED, on this 17th day of August, by the Board of Trustees of the County College of Morris that Dobtol Construction, LLC be awarded the contract for Bid #B1617-2JK for the Pre-Engineered Metal Storage Building in the amount of \$644,000.00.

Trustee Jinks seconded the motion. Chair Ricca called for discussion by members of the Board. There being no questions or comments, Chair Ricca called for a roll call vote of the Board. At this time, Chair Ricca acknowledged the retirement of President Yaw with this as his last Board of Trustees meeting. President Yaw was presented with a gift from the Trustees. President Yaw responded with words of thanks and recognition.
