COUNTY COLLEGE OF MORRIS BOARD OF TRUSTEES MINUTES REGULAR MEETING

September 17, 2019

CALL TO ORDER

Board of Trustees Chair Paul R. Licitra called the regular meeting of the Board of Trustees of the County College of Morris to order at 6:00 p.m., in the Board Room, Henderson Hall. Chair Licitra stated that in compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of this rescheduled Regular Meeting of the Board of Trustees was provided on August 14, 2019. Advance written notice of this meeting was posted on the bulletin board outside the President's Office, was sent to the Star Ledger and Daily Record, and was filed with the Clerk of the County of Morris.

ROLL CALL

Trustees Advokat, Aprile, Frost, Hadzima, Milonas, Pepe, Weisberg, and Chair Licitra were in attendance. Trustees Allen-McMillan, Dredden, and Alumni Trustee Otero Lopez were absent. President Iacono and Attorney Chait were also in attendance.

ADVANCED MANUFACTURING AND ENGINEERING BUILDING UPDATE

Vice President Karen VanDerhoof provided an update on the Advanced Manufacturing and Engineering building. The steel is being erected. Current projection is that the building will be complete in March 2020 with a soft opening in the Summer 2020, and ribbon cutting in Fall 2020.

COMMITTEE ON ACADEMIC AND EDUCATIONAL PROGRAMS

Trustee Weisberg seconded the motion. Chair Licitra called for discussion by members of the Board. There being no questions or comments, Chair Licitra called for a roll call vote of the Board. The roll call vote of the Board indicated that all were in favor. The Report of the Committee on Academic and Educational Programs was concluded.

COMMITTEE ON ORGANIZATION, BYLAWS, PLANNING AND NOMINATION

Committee Chair Advokat reported that the Committee has created a list of questions for the Board Self-Assessment. The self-assessment will be conducted with an online survey to be completed within one week. The Board will consider at the November organization meeting a slate of officers recommended by the Committee. The Trustee retreat is scheduled for Saturday, December 7, 2019. The Report of the Committee on Organization, Bylaws, Planning and Nomination was concluded.

MATTERS TO BE BROUGHT TO THE ATTENTION OF THE BOARD BY OFFICERS OF THE BOARD.

Trustee Advokat reported that the New Jersey Council of County Colleges has a Council meeting scheduled on September 23, 2019 to which all Trustees are invited. The Foundation is hosting an Athletics Hall of Fame dinner on November 16, 2019.

Trustee Weisberg credited the leadership of President Iacono for the positive changes being seen on campus.

QUESTIONS AND COMMENTS FROM THE PUBLIC

Chair Licitra called for questions and comments from the public at 7:47 p.m.

Dr. Candace Halo stated that she was addressing the Board at the request of the Faculty Association of CCM (FACCM) and was reading from a prepared statement. Dr. Halo said that the college is about teaching and learning; she understands that the Board's management and fiduciary responsibilities are important but she had a request of the Board. Dr. Halo advocated for more opportunities for the Board to have face to face contact with faculty and students.

Professor Dee McAree, FACCM Secretary, addressed the Board. Prof. McAree commented that she echoes the remarks of Dr. Halo. Prof. McAree said that many faculty feel they are stakeholders of the college. She commented on the activities being planned by the Legacy Project and noted the speakers, and quality enrichment programs. She stated that hearing from the faculty is important. Chair Licitra responded that faculty are free to speak to the Board during the "Questions and Comments from the Public" section of the meeting.

Professor Jim Capozzi, FACCM President, addressed the Board. Prof. Capozzi expressed that he appreciates the willingness of the Board to hear the concerns of faculty. Prof. Capozzi stated that all the faculty accomplishments highlighted in the convocation video occurred without a contract. Prof. Capozzi said that faculty are concerned and asked for time on the next agenda of the Board of Trustees. Attorney Chait responded that any comments for the Board would be received during the "Questions and Comments from the Public" section of the meeting.

There were no further questions or comments from the public.

The being no further business to conduct, the public meeting was adjourned at 8:10 p.m.
